SECURITY COUNCIL AL-QAIDA SANCTIONS COMMITTEE DELETES ABDELHADI BEN DEBKA FROM ITS SANCTIONS LIST

The Security Council Committee pursuant to resolutions 1267 (1999) and 1989 (2011) concerning Al-Qaida and associated individuals and entities removed the name of the individual below from the Al-Qaida Sanctions List after concluding its consideration of a de-listing request submitted through the Office of the Ombudsperson established pursuant to Security Council resolution 1904 (2009), and after considering the Comprehensive Report of the Ombudsperson on this de-listing request.
