3. The list of individuals and entities designated by the United Nations Security Council Committee established pursuant to UNSCR 1718 (2006) concerning **North Korea**, which is referred in Regulation 19 of the United Nations Regulations (Sanctions in relation to Democratic People's Republic of Korea) Regulations of 2017 (**DPRK List**) has **80 Individuals and 75 Entities** as of August 27, 2024. 4. The restrictive measures contained in paragraphs 3, 4 and 6 (c) and (d) of Annex B to resolution 2231 (2015) applied until the date eight years after Adoption Day of the Joint Comprehensive Plan of Action. Adoption Day occurred on 18 October 2015.  
As a result, the Secretariat has removed on 19 October 2023 from the Security Council website the list of 23 individuals and 61 entities subject to the aforementioned restrictive measures.  
**Accordingly, the designated list of individuals and entities for UNSCR 2231 (Iran) is no longer in effect.**
